

Tariff Item 100 - Rules and Regulations

Express Havre St Pierre (EHSP) reserves the right to assess the following charges which are subject to change without notice. Charges will be applied according to the terms of the bill of lading unless otherwise specified.

100.005	APPOINTMENT DELIVERY:	<p>Per shipment charge of \$45.00 This charge applies when a shipment requires:</p> <ul style="list-style-type: none"> a) a specific appointment time of delivery or; b) delivery window less than 3 hours c) delivery during a specified range of time that does not allow the delivery to occur with regular operating procedures. <p>The bill of lading or any shipping document must have a notation requesting the prearranged time of delivery or specified range of time. The charge also applies if requested by the consignee. EHSP Transport will do the delivery on a best efforts basis and will not be liable for any consequential damages, costs, and/or fines as a result of shipment delay.</p>
100.015	BLIND SHIPMENT CHARGE	<p>\$25.00 per request This charge applies when, prior to delivery, EHSP Transport is asked to change the Shipper's information and/or the Consignee's information from the Original Shipper's Bill of Lading. Blind shipments may require the relabelling of freight, removal of packing slips or invoices, and substituting a new Bill of Lading.</p>
100.025	CARRY IN DELIVERY OR PICK UP:	<p>\$5.81 per cwt. Minimum \$34.50, Maximum \$275.15 This charge will apply if inside pick-up or delivery is requested from/to floors other than ground floor or the pickup or delivery is sixty feet from the delivery vehicle.</p>
100.045	CROSS DOCK CHARGE:	<p>\$10.00 per skid. This charge applies when the consignor has delivered a shipment to EHSP's dock for a consignee to pick up.</p>
100.050	CUBE (DENSITY):	<p>All rates are subject to 10 pounds per cubic foot (pcf) unless otherwise specified. $10 \text{ pcf} = \text{Length (in)} \times \text{Width (in)} \times \text{Height (in)} \div 1728 \times 10$. If this amount is more than the actual weight of the shipment then the cubed weight would apply to calculate the freight charges. When it is not possible to load on top of a shipment, the cube dimension for that shipment shall be based on a minimum height of 8 feet.</p>

100.060	DANGEROUS GOODS:	Per shipment charge of \$37.00 up to 10,000lbs. 10,001 and over \$75.00. Cross border per shipment charge \$150.00.												
100.070	DETENTION WITHOUT POWER:	\$150.00 per day per trailer. The above rates will be given a free period of 24 hours after notification of availability. Saturdays, Sundays and Holidays will not be used in the computation of free time, but will be included in the assessment of charges.

100.116	FUEL SURCHARGE:	Rates and charges are subject to the applicable fuel surcharge in effect at the time and place of shipping.												
100.118	HEAT SERVICE:	Expedite -12% of freight charges Minimum \$25.15 & Maximum 156.40\$. This service will be provided when the shipper specifies on the Bill of Lading, HEAT or PROTECT FROM FREEZING; the above charges apply.												
100.119	HOUSE DELIVERY:	\$100.00 per shipment. (Includes tailgate) This charge is applied when we pick up or deliver at a property that is a Private Residence whether the property operates as a business or not.												
100.120	HYDRAULIC TAILGATE SERVICE:	\$3.70 per cwt., \$50.00 Minimum - \$130.00 Maximum. (shipments to indirect points will be subject to interline carrier rules and regulations). Charge applies if the shipper or the consignee does not have a proper shipping / receiving dock to ensure safe handling of the freight or the shipper or consignee states that the use of a hydraulic tailgate is a requirement.												
100.140	LABOUR CHARGES:	\$16.95 per person per 1/4 hr. or part thereof - Min. 4 hours The above represents the cost of a drivers helper only. This charge would be applied if the driver required a helper to load or unload the freight. It is applied to the total time spent performing the work required, including the time from the domicile terminal and return.												

Tariff Item 100 - Rules and Regulations

100.150	LINEAR FOOT RULE:	1000 pounds per linear foot for shipments occupying 10 feet or more of trailer. When the freight occupies 10 feet of trailer space or more (or is packaged in such a way that other freight cannot be stored on top of or on either side of it), the chargeable weight will be calculated at 1000 lbs per linear foot of space used. (i.e.: 25 feet of trailer space used = 25,000 lbs). See also, Cube (Density).
100.161	LONG FREIGHT HANDLING:	Applicable for parts with a width of 12 inches and less : Pieces 18' and up to 30' – subject to a minimum weight of 3,000 lbs. Pieces 30' and over – subject to a minimum chargeable weight on 5,000 lbs.
100.165	OFF HOUR PICKUP / DELIVERY:	\$75.00 per shipment plus \$2.81 per mile for road miles in excess of 40 round trip. This charge applies in addition to the prescribed freight charges for pickups / deliveries that fall within the time period of 7:00 p.m. to 7:00 a.m., for shipments under 24,000 lbs. This service requires to be pre-arranged 24 hours in advance. Any detention time will be charged in addition as per item 100.080. Item 100.005 does not apply when this service is provided.
100.119	PRIVATE RESIDENCE/ RURAL ROUTE:	\$100.00 per shipment. (Includes tailgate) This charge is applied when we pick up or deliver at a property that is a Private Residence whether the property operates as a business or not.
100.118	PROTECTIVE SERVICE (HEAT):	Expedite -12% of freight charges Minimum \$25.15 & Maximum 156.40\$. This service will be provided when the shipper specifies on the Bill of Lading, HEAT or PROTECT FROM FREEZING; the above charges apply.
100.205	RECONSIGNMENT:	\$50.00 per request. This charge is applied when, prior to the delivery, the consignee address on the original shipper's bill of lading is requested to be changed to another local address within the terminal service area and a new bill of lading may be required for the shipper in order to direct the shipment properly.
100.210	REDELIVERY/ ATTEMPTED PICKUP:	\$6.50 per cwt. Minimum \$50.00 - Maximum \$275.00 a) REDELIVERY: This charge is applied when we have attempted to deliver freight and one of the following happens: <ul style="list-style-type: none"> • Consignee requests we deliver at another time; • No answer at consignee's place of business; • Consignee or Shipper request we deliver to another address within the terminal service area, not originally noted on Bill of Lading; • Access to delivery area at time of delivery was restricted. b) ATTEMPTED PICKUP: This charge is applied when we have attempted to pick up freight and one of the following happens: <ul style="list-style-type: none"> • Shipper requests we pick up at another time; • No answer at shipper's place of business; • Consignee or Shipper request we pick up at another address within the terminal service area, not originally noted on Bill of Lading; • Access to loading area at time of pickup was restricted.

100.220	REWEIGHING OF SHIPMENT:	Shipments are subject to reweighing using weight and measure Canada approved scales. For shipments subject to reweighing, the product, container, packaging, pallet and any other item attached to or part of the shipment will be included in the reweighed weight.
100.223	SHIPMENT DELAY:	EHSP and its partners will not be liable for any costs and/or fines as a result of shipment delay, late deliveries or pickups or by missed appointments.
100.230	STOP OFF IN TRANSIT:	Maximum 3 stops \$100.00 per stop This charge applies when our customer chooses to pay a truckload rate to the furthest point and an additional charge for <u>stops in the direct line of haul</u> . The largest delivery will be allowed 2 hours for delivery and all subsequent deliveries will be allowed 1 hour each.
100.240	STORAGE CHARGES:	\$10.00 per skid position, per day. This charge applies when a customer asks us to store undelivered freight or freight awaiting transportation. <ul style="list-style-type: none"> • Freight Awaiting Transportation will begin at 7:00 am the day after the freight is received by the carrier. • Undelivered Freight will be allowed 24 hours free time from the notice or arrival. Saturdays, Sundays and Holidays will not be used in the computation of free time, but will be included in the assessment of charges.
100.250	SURCHARGES:	All rates are subject to applicable surcharges.
100.120	TAILGATE SERVICE:	\$3.70 per cwt., \$50.00 Minimum - \$130.00 Maximum. (shipments to indirect points will be subject to interline carrier rules and regulations). Charge applies if the shipper or the consignee does not have a proper shipping / receiving dock to ensure safe handling of the freight or the shipper or consignee states that the use of a hydraulic tailgate is a requirement.

100.255	TARPING:	\$100.00 per trailer or part thereof. This charge applies when a tarp is requested or required in order to protect the freight from the elements.
100.260	TAXES:	All rates are subject to applicable taxes.
100.265	TERMS OF PAYMENT	Freight charge are due 30 days from date of shipment subject to interest charges on overdue accounts at 2% per month (24% per annum). Payments are to be made by cheque or direct deposit (EFT-Electronic Funds Transfer). Outstanding loss or damage claims are not to be offset from freight charges.
100.270	TRADE SHOW SURCHARGE:	\$150.00 per shipment. \$500.00 per US shipment. The above charge does not apply if we are the official carrier for the show.
100.290	VALUATION:	Liability for damage and loss will be the lessor of the depreciated actual value, \$2.00 CDN per pound on the actual weight of the shipment or the declared value noted on the Bill of Lading with a maximum of \$50,000 CDN per shipment. Declared value in excess of \$2.00 CDN per pound is subject to a valuation charge of 5%. Valuation charge = (declared value - (2 x actual weight)) x .05
100.300	WEEKEND OR HOLIDAY CHARGE:	\$175.00 for Saturday, \$450.00 for Sunday or Holiday requests. This charge applies in addition to the prescribed freight charge whenever we are asked to perform pick up or delivery on a Saturday, Sunday or holiday and it is necessary to call a driver in to perform the service.
100.350	WEIGHING:	Subject to \$15.00 per shipment This charge applies when the Bill of Lading tendered does not specify a weight for the shipment and EHSP Transport is required to weigh the freight.
